

Terms & Conditions

Stand Up & Sing: Manassas Mall & Uptown Alley Manassas 2018

1. Entry Procedure
 - a. Applicants must complete a Contest Entry Form and return it to the venue with registration fee before their deadline date. The entry form can only come from venue, venue website or Manassas Mall website.
 - b. Audition Time Slots will be assigned after registration.
2. Registration Fee
 - a. Applicants/acts must pay a onetime registration fee of \$15.00 USD. United States currency only accepted. Applicants only pay the fee once, regardless of the number of times they perform.
 - b. Registration fee is non-refundable.
3. Disputes
 - a. The venue and sponsors are authorized to resolve all disputes at the shows. The venue and sponsors have the authority to disqualify any contestant at any level of the contest for failure to comply with the rules and regulations of the contest and venue including errors and omissions. Decisions are final.
4. Performance: the following applies to any level in the contest
 - a. Each act entered must perform only with the individuals listed on the entry form. No changes or substitutions will be permitted once the competition has begun. Once an individual withdraws from an act at any level of the contest, he/she cannot perform at the next level.
 - b. Individuals may perform with only one act during each level of the contest.
 - c. Each act must perform live, vocally and/or instrumentally. No special lighting, props or special effects may be used.
 - d. Any act with three or more individuals playing an instrument may not use prerecorded music.
 - e. The amount of performance time given to each contestant will be determined by the venue and sponsors.
 - f. All performances must be done in good taste: no music or lyrics that the venue or sponsors consider to be offensive may be performed.
 - g. The venue & sponsors are not responsible for delays, bad sound or anything other things that may detract from the acts performance.
 - h. Contestants cannot perform the same song at multiple levels of the contest except for the finale.
 - i. Age restrictions will be at the discretion of the venue and sponsors.
 - j. Contestants may perform their own music.
 - k. Performances will be awarded 0-10 points in each of the following categories
 - i. Marketability
 - ii. Vocal ability
 - iii. Originality
 - iv. Stage Presence/Charisma
 - v. Talent

- I. In the event of a tie, the first tiebreaker shall be the highest number of points given in the Talent category. The second tiebreaker shall be the highest number of points given in the Stage Presence/Charisma category. The third tiebreaker shall be a secret vote of the judges based on overall performance style and impact.
5. Set Up Time
 - a. Bands with drums may be disqualified if they exceed 10 minutes setup time on stage.
 - b. Vocal only and acoustic acts may be disqualified if they exceed 2 minutes on stage setup time.
6. Local Contest Prizes
 - a. The only official prize offered at the beginning level is the opportunity for the winner to advance to the next level of the competition.
 - b. The grand prize for the final winner on Tuesday August 29th, 2017 is \$1,000.00 in studio time at Cue Recording Studios plus a \$250.00 American Express Gift Card
 - c. The runner up will receive a prize of \$500 cash value for rehearsal space at Bach 2 Rock plus a \$150.00 American Express Gift Card
 - d. The third place winner will receive a prize of \$100.00 American Express Card and Family Fun Pack from Uptown Alley valued at \$150.00
7. Finals
 - a. The final level of the competition will be held on Tuesday August 29th where the top 3 will compete with 2 songs no longer than 5 minutes each for the grand prize.
8. Promotional Authorization
 - a. By submitting an Entry Form, the act (and each individual member thereof) grants permission to the venue and sponsors to utilize the act's name, likeness, image, voice, appearance and performance in perpetuity for advertising, trade or any other lawful promotional purpose whatsoever in any media form without compensation.
9. Assumption of Risk
 - a. By submitting an Entry Form, the act (and each individual member thereof) assumes all risks of property damage, emotional damage or bodily injury (including death) that might occur during the contest. The act (and each individual member thereof) agrees not to bring against the venue, any sponsor, designated and alternate judges, MC, sound technician, or any persons involved in the production or planning of the contest any claim for damages, emotional damage, property damage or bodily injury (including death) that might occur in the co.
10. Good Character
 - a. The act agrees that it may be disqualified immediately from any level of the contest competition if the act (or any member thereof) commits any act or becomes involved in any situation that would adversely reflect on the show or any party furnishing a prize, or tend to bring it into public disrepute.
11. Eligibility
 - a. Submit any questions regarding eligibility to (TBD)
 - i. I am/we are a singing act
 - ii. I am/we are at least 10 years of age
 - iii. I am/we are not an act with over four individuals
 - iv. I/we have not performed on a record listed in Billboard within eighteen months preceding local competition

- v. I/we have (each) paid the \$15.00 registration fee before performing live at the local showdown
- vi. I am/we are not an owner, controlling stockholder or employee of and I am/we are not related by birth or marriage, nor do I/we live in the same household as the local showdown judges, sponsors or stockholders.
- vii. I am/we are not an act with more than 2amps
- viii. I am/we are not an act with more than 1 set of drums
